Anna White, a student at Perkiomen Valley High School, did her senior project concerning speeding on Evansburg Road between Kratz Rd. & Rt. 73. She stated the speed limit is 25mph but most motorists exceed the limit. She requested the Supervisors assistance to enforce the speed limit by painting the roadway or by signage.

Wendy White requested white crossbars at Evansburg and Kratz Rds., at the trailhead beginning on the McGinnis Tract.

Janice Sames questioned surveying along the Perkiomen Creek behind her residence. Mr. Woodrow stated his crew was out surveying for the possible trail extension. Mrs.Sames stated she would be opposed to a trail on her property.
