**5:30pm** – A Conditional Use Hearing was conducted pursuant to the Municipalities Planning Code on the Application of PS Capital Partners, LLC for the property located at 4335 Skippack Pike. The applicant requested a Conditional Use order pursuant to Skippack Township Zoning Ordinance \$200-27.C(2)(a) to allow an events venue within the GC-General Commercial District, upon real properties commonly referred to as 4335 Skippack Pike, and more specifically designated as Montgomery County Parcels 51-00-03169-00-2 and 51-00-01276-53-6.

A Conditional Use Hearing was also conducted pursuant to the Municipalities Planning Code on the Application of Lehigh Valley Underground, LLC for the property located at 2031 Cressman Road. The applicant requested a Conditional Use order pursuant to Skippack Township Zoning Ordinance 8200-29.C (2) to allow a contractor's storage yard enclosed by fencing, within the LI – Limited Industrial District, upon real property commonly referred to as 2031 Cressman Road, more specifically designated as Montgomery County Parcel 51-00-01306-00-2.

#### VIII. NEW BUSINESS

A. 3853 Skippack Pike, LLC – Preliminary/Final Land Development application - Kevin Fruck, Cornerstone Consulting Engineers, presented plans for a proposed parking lot extension at the property located at 3853 Skippack Pike, on behalf of the applicant. A review letter from Mr. Woodrow was addressed. Mr. Woodrow also suggested that the driveway be widened for easier access. There are no proposed additions or modifications to the existing structure.

### IX. COMMENTS FROM THE BOARD

Ms. Lynch shared that she would be attending a "best practices" meeting regarding plans for the upcoming America250 celebration in 2026. She noted that she would be attending in a dual role as Township Supervisor and a member of Skippack Historical Society.

Ms. Ellis shared that she received a call from a neighbor regarding the draught and poor grass conditions. She inquired on his behalf if future land developers could restore topsoil instead of removing it when construction is complete. The neighbor also inquired about the use of open space for stormwater retention basins.

Mr. Fountain shared that he and Mr. Fox had been invited by Representative Bradford's office to a meeting to receive updates on the Youth Development Center at SCI Phoenix. There are currently three residents, with that number supposed to increase in the coming weeks. Construction was still in progress at the time of the meeting. Mr. Fountain also shared that Senator Pennycuick's office had informed them of an attempted escape at the prison. The Senator is working on reforms to the prison at the state level.
