# **REGULAR MEETING:**

### I. ANNOUNCEMENT OF EXECUTIVE SESSION

Mr. Fox announced that the Board discussed staffing and personnel at an Executive Session prior to the meeting.

### II. PRESENTATIONS

The Board of Supervisors recognized Skippack Township resident Ryan O'Connor who built an addition to the Little Free Library in Palmer Park for his Eagle Scout Community Service project. The addition to the library is lower for easier access to children's books.

### III. PUBLIC SAFETY REPORT

**A.** Skippack EMS Monthly Report – President Barry Evans gave the monthly report from SEMS. He noted that a new substation was opened in Trappe Borough.

## IV. PUBLIC COMMENT

David Dolenti expressed concerns with the property located at 2031 Cressman Road.

Mr. Fox allowed for public comments on the New Business agenda item – Discussion of Outdoor Amplified Music. Ms. Lynch gave an update on Act 67, which was passed in 2022 and loosened regulations for establishments playing outdoor music. Ms. Eastmure added that the PA Liquor Control Board had recently issued a warning to a Skippack restaurant and held a meeting with restaurant owners to discuss the procedures in place.

Kelley Tyrell expressed concerns with the volume of outdoor music.

David Jones expressed concerns with the volume of outdoor music.

Several residents expressed their appreciation for the live music in Skippack.

Several non-residents expressed their appreciation for the live music in Skippack and shared that they enjoy traveling here to patronize the venues that feature musicians. ### VI. ADMINISTRATIVE ACTIONS

- A. Treasurer's Report as of October 31, 2024 Ms. Nonamaker noted that the year is going well. Motion made by Ms. Lynch, seconded by Mr. Fountain, to accept the Treasurer's Report as of October 31, 2024. All in favor, motion carried.
- B. Consideration of Resolution 2024-27 authorizing advertisement of the proposed budget for 2025 Ms. Nonamaker noted that the budget allowed for assistance to the Skippack Fire Company and Skippack EMS, while keeping road improvements intact for 2025, as well as some IT upgrades. Mr. Fox noted that there would be no tax increase, but that \$250,000 would be set aside for each of the emergency services, provided they make requests and share updates at public meetings. Motion made by Ms. McGinnis, seconded by Mr. Fountain, to approve Resolution 2024-27 authorizing advertisement of the proposed budget for 2025. All in favor, motion carried.

Consideration upon Resolution 2024-30 granting a waiver from the formal land development procedural requirements and granting preliminary/final land development approval to 2031 Cressman Road, Lehigh Valley Underground Motion made by Ms. McGinnis, seconded by Mr. Fountain, to approve Resolution 2024-30. All in favor, motion carried.

Motion made by Mr. Fox, seconded by Mr. Fountain, to approve the Conditional Use application of PS Capital Partners LLC for an events venue within the GC-General Commercial District at the property located at 4335 Skippack Pike subject to a list of conditions set forth by Mr. Kuhls. All in favor, motion carried.
- 5. Motion made by Mr. Fox, seconded by Ms. Lynch, to approve the Conditional Use application of Lehigh Valley Underground for a contractor's storage yard within the LI-Limited Industrial District at the property located at 2031 Cressman Road subject to a list of conditions set forth by Mr. Kuhls. All in favor, motion carried.
